Marmor, G. &Petitto, L. (1979) conducted an experimental study to analyze how well is grammar represented using Simultaneous Communication and American Sign Language (ASL) in the classroom. To check the effectiveness, the researcher collected samples of communication from two hearing teachers and tested at a large residential school for Deaf children. The study attempted to find the difference between teachers' spoken and signed utterance with reference to grammatical construction. Based on the results, signed utterance were ungrammatical whereas simultaneous communication offered and made salient.

**Crowhurst** (1983) examined the association between syntactic complexity and quality of written composition. He collected the reviews and examined into two broad divisions. They were intervention based studies and a set of diverse studies. Results showed that the basic knowledge in grammar facilitate the students to enhance their written communication.

Mitchell, J. T., & Redmond, M. L. (1993) attempted to examine the difference views on grammar. They revisited the problematic areas of grammar. Based on the findings of the study, the association of grammar and communication can bring the positive classroom climate. According to the study, classroom communication and grammar explanations facilitate real communication in the target language.

**Zhongganggao, D. R.** (2001) made an experimental study on distinguish between early age and adult age learners. This paper attempted to give the different process of learning in the first and the second language acquisition. He argued that mother tongue was acquired with the rich cultural background and linguistic environment. Comparatively, the learners did not have

the rich platform to acquire the second language. He states, "Grammar as a catalyst for second language accuracy and fluency."

**Batstone, R., & Ellis, R.** (2009) wrote an article titled principled Grammar Teaching. In this article he states, "A key aspect of the acquisition of grammar for second language learners involves learning how to make appropriate connections between grammatical forms and the meanings which they typically signal."

**Jianyun Zhang (2009)** wrote a paper on, "Necessity of Grammar Teaching." In this paper he argued, "Grammar teaching is necessary in language teaching." Further he stated "Grammar is not acquired naturally; it needs be taught." It is true that learners of second language cannot be possible to learn its grammar without instruction. He concluded that it is difficult to learn grammar on their own.

Shengmei Wang (2010) published an article entitled, "The significance of Grammar to Middle School Students in China." He argued, "Grammar has always been playing a role in foreign language teaching and learning." He also pointed out, "The central part of a language is its grammar." He highlighted the theoretical approaches to grammar teaching from grammar in the GT method followed by Situational Language Teaching (SLT), Audio-lingual Method and Communicative Language Teaching Method in China.

Herring, S. C. (2012) studied the importance of digital communication and grammar. This study was dealt with typography, orthography, morphology, and syntax in e-grammar. E-grammar referred as the grammar of electronic language. It is found from the study that the prediction of earlier writers was that the internet could have the possibility to change the language worse. Based on the findings, it is revealed that many young learners are the part of using e-grammar in their offline writing.

**Debata** (2013) studied the importance of grammar in communication. He stated the association of grammar and communication in his paper. He also highlighted the genesis of grammar. Additionally, he pointed out different types of interpretations and discussions of the most outstanding grammarians of English language acclaimed widely. The study concluded that grammar helps to master over its four basic skills.

**Samuel Praise & Meenakshi. K** (2015) made an analysis of the importance of grammar in communicative competence. They state, "Grammar is the foundation for communication, which helps in understanding the meaning and intent of a message." They divided the language teaching into three phases where they discussed the role of grammar through contemporary methods. Therefore, theyconcluded that one can have the control of expression and effective communication skill by learning grammar.
